
The Inner Temple Library holds hard copy resources and provides access to electronic resources for various Commonwealth jurisdictions.

Subscription databases

Our subscriptions to Lexis+, vlexJustis (JustisOne) and Westlaw provide access to a range of jurisdictions.

The home page on the PCs in the Library gives direct access to these databases.



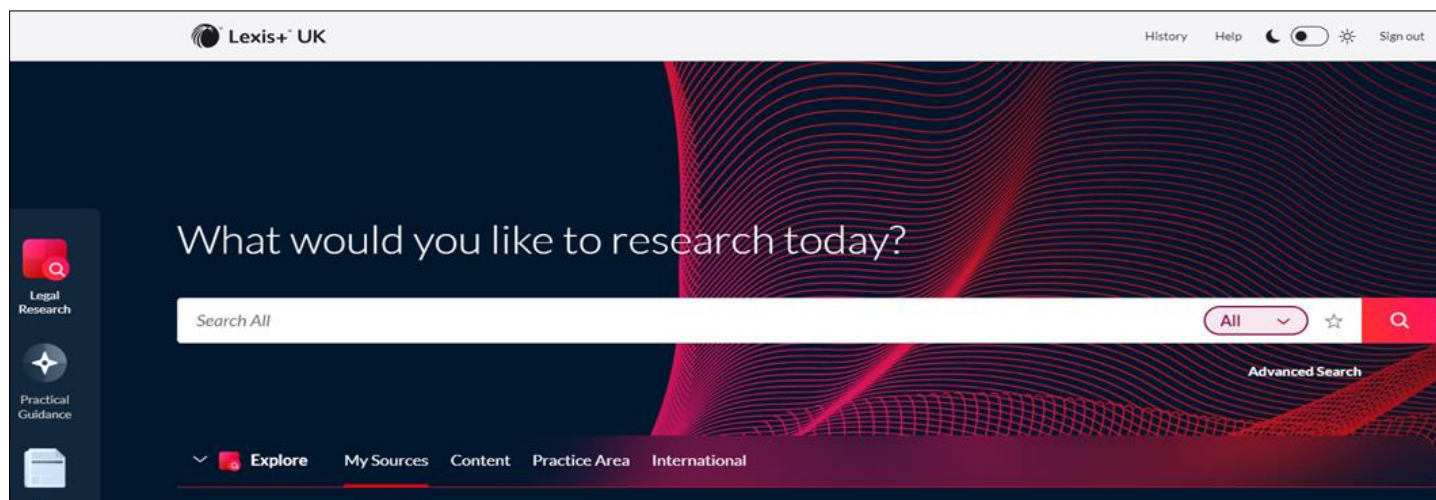

From the homepage click on the International tab. From here you can access materials relating to Australia, Canada, Hong Kong, India, Malaysia, New Zealand and Singapore.

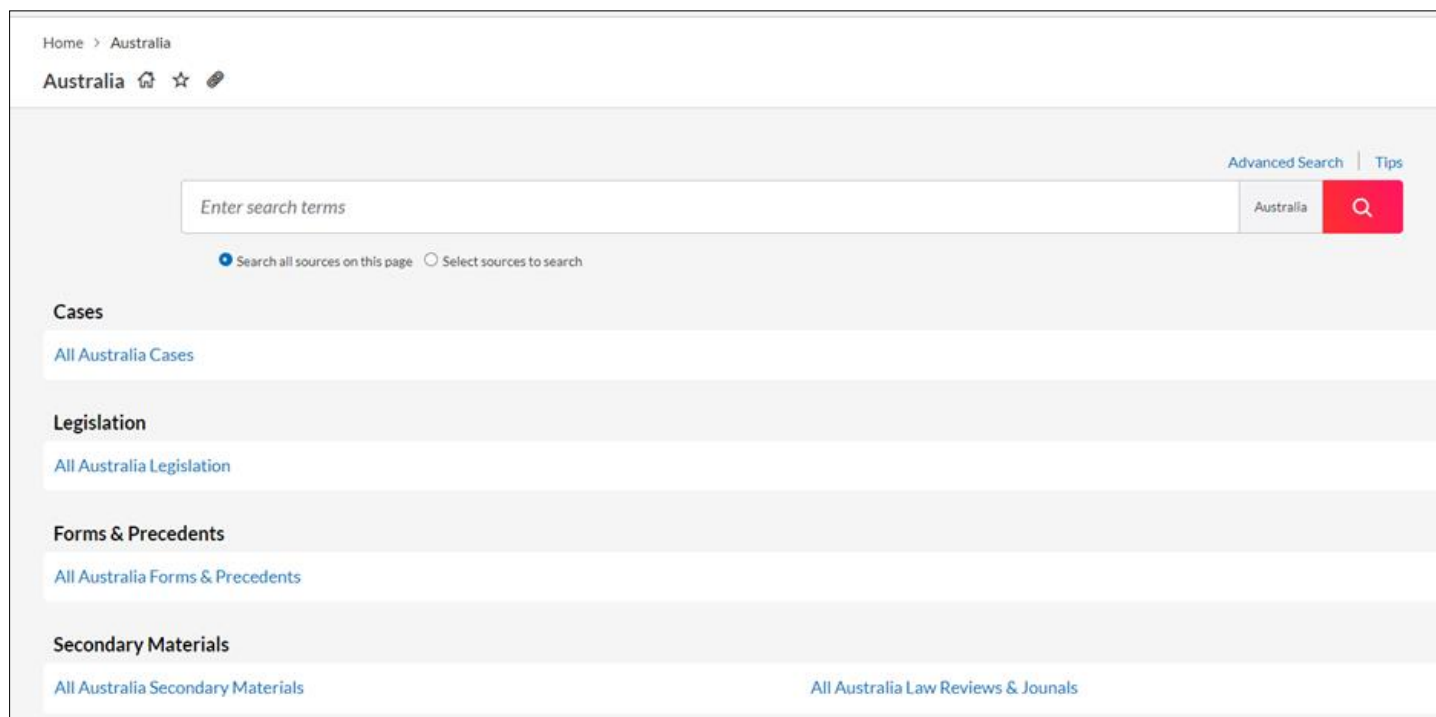
Note that you cannot search across all these jurisdictions.



Searching

Select the country you need. The central search box allows you to search across all content.

For most countries there are options to search cases, legislation, forms & precedents and secondary sources.



Under each category heading there is the option “All” e.g. All Australian Cases. Click on this to see a list of all the sources within that category.

To search across several sources, click on the “All” option but also tick the button “Select sources to search”. This will allow you to select the sources you want to search across.

The sources selected will be indicated under the search box. Now you can add your search terms.

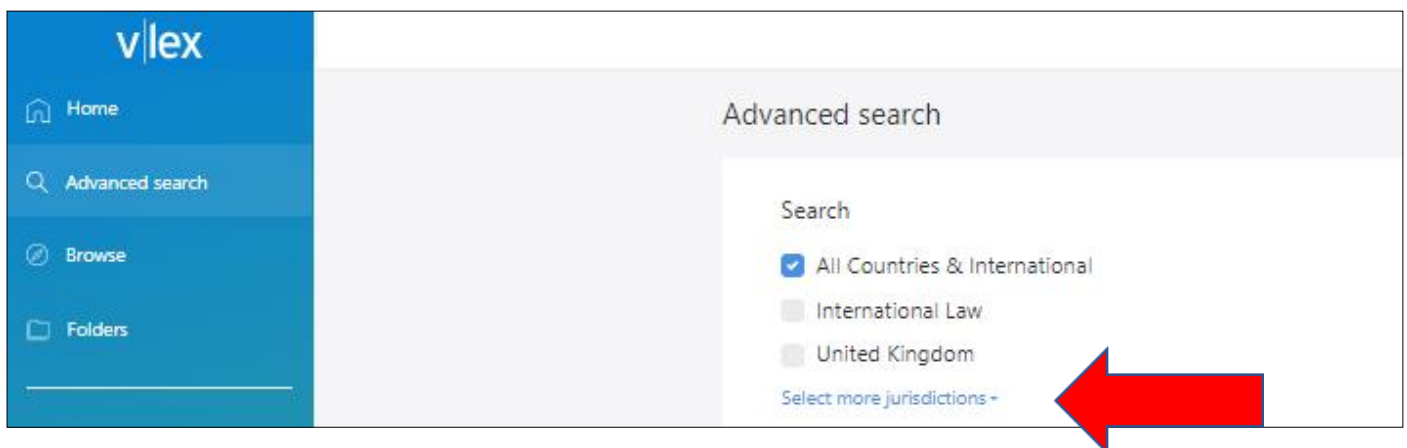

A list of search results will appear. Click on the item you need and the document will appear.

Legislation

To find a piece of legislation, there are 4 options: All Canadian Legislation; Statutes; Regulations and Rules.

If you select **All Canadian Legislation**, you can search across the database or you can select a jurisdiction or all federal legislation.

For each option you can choose to search across each individual database or browse lists of legislation.

Once you have found the legislation, it will appear in the form of a Table of Contents. Select the section you need or use the search box at the top of the screen to search within the piece of legislation and then click on the relevant section.

The text will appear on screen.

At the top of the page various tabs will appear: Citing References (for cases citing the section); Annotations; Legal Memos. Where these tabs are greyed out there is no material available.



26. Guardianship order
26(1) An interested person may apply to the Court, in accordance with this section and the regulations, for an order appointing a guardian for an adult.
26(2) Where, in the opinion of the Public Guardian, an adult is in need of a guardian and no person is willing, able and suitable to make an application for the appointment of a guardian, the Public Guardian shall, in accordance with the regulations, apply to the Court for an order appointing a guardian for the adult.
26(3) The following documents must be filed in support of an application for a guardianship order under this section:
(a) subject to section 105, a capacity assessment report respecting the adult who is the subject of the application,
(b) a guardianship plan in the prescribed form, and
